

# CROWN POINT WINTER TIMED FINAL INVITATIONAL

January 8, 9, & 10, 2010

Sanction: This meet is sanctioned by United States Swimming Inc. and Indiana Swimming. Sanction # IN10004

Location: Crown Point High School, 1500 S. Main Street, Crown Point, Indiana

Facilities: 8 lane, 25 yard pool with starting blocks, non turbulent lane markers, automatic timing system with 2 backup timers per lane, and a diving well used for warm up/down that is part of the main competition pool. Place judges will be used.

Rules: Current USA Swimming and Indiana Swimming rules will govern this meet. USA Swimming Rules 202.3.2 – At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision. All swimmers must compete in their own age group.

All 12 and under swimmers participating in a meet sanctioned by the Indiana LSC must comply with the new swimwear rules passed into legislation by the 2008 Indiana Swimming House of Delegates. This legislation modifies USA Swimming rule 102.9.1 as follows:

A. Swim suits worn by 12 and under males participating in all Indiana Swimming sanctioned “age group” competitions will not extend above the navel or below the knees.

B. Swim suits worn by 12 and under females participating in all Indiana Swimming sanctioned “age group” competitions will not cover the neck, extend past the shoulders; extend beyond the shoulder, nor below the pelvis.

C. Swimsuits worn for competition must be non-transparent and conform to the current concept of appropriate.

D. The referee shall have the authority to bar offenders from the competition until they comply with the rule.

Eligibility: Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of January 8, 2010 shall determine the swimmer’s age for the entire meet.

Entry Limits: All 11 & over swimmers may swim 2 events on Friday and 4 events per day on Saturday and Sunday PLUS 1 relay each day. All 10 & Under swimmers may swim 2 events on Friday and 4 events per day on Saturday and Sunday PLUS 1 relay each day. Entries will be limited to the first 3,500 or a 4 hour time line is achieved, whichever comes first. Refunds will be given to any team not accepted due to entry limit.

Entries: Should an error occur, we will only accept the original entry forms produced from Team Manager as proof. Only under these circumstances will a swimmer’s event be changed. NT (No Time) will be accepted only if a swimmer has never swum the specific event. Experienced swimmers should enter their actual times.

Entry Information: All times are requested to be completed to the hundredth of a second and SUBMITTED in SHORT COURSE YARD TIMES. However, we will seed the meet first by Yards, then LC Meters, and finally SC Meters. For all events, please submit actual times; estimated yard times, or "No Time" will also be accepted. **Experienced swimmers should enter their actual times.** Please enter each swimmer with their first and last names, age, and USA number on the entry. **Entries will not be accepted before 9:00 a.m. November 30, 2009. Entry Deadline will be December 18, 2009.** Crown Point Swim Club reserves the right to extend the deadline should the meet not fill. NO TELEPHONE ENTRIES will be accepted. Please make one check payable to: Crown Point Swim Club and enclose it with your entry. This meet will be run using Hytek Meet Manager computer program. Diskette & e-mail entries will be the preferred method of entry using the Hytek Team Manager program (**do not forget to "age up" swimmers**). A printed copy must accompany the diskette; a printed copy must be sent in addition to an e-mail. Each entry accepted via e-mail will be confirmed via a return email receipt. E-mail entrants who fail to bring the printed copy & fees due by January 8, 2010 will forfeit entry into the meet. The printed copy is the final word in any disputes involving entries. Deck Entries: Deck entries for individual events will be accepted, at the discretion of Crown Point Swim Club, provided the meet is not filled and ONLY as NEW ADDITIONS; CHANGES TO EXISTING ENTRIES WILL NOT BE ACCEPTED. Entry fee for deck entries is \$5.00 for an Individual event or \$10.00 for a relay, payable at the time of the entry.

Awards: INDIVIDUAL EVENTS: Swimmers placing 1<sup>st</sup>-16<sup>th</sup> will receive a ribbon.

RELAY EVENTS: Medals will be given for 1st-3rd place finishes.

***OPEN events will not be awarded any ribbons, medals, or high point but will be scored.***

INDIVIDUAL HIGH POINT: First place, runner up and 3<sup>rd</sup> place high point awards will be given for each age group; boys and girls. (excluding OPEN age group)

TEAM TROPHIES: Team trophies will be given for 1<sup>st</sup>, 2<sup>nd</sup> & 3rd place. (CPSC not eligible for team trophy.)

Scoring: Individual Events for Finals: 20-17-16-15-14-13-12-11 / Consolations: 9-7-6-5-4-3-2-1 in individual events. Relay Events for Finals: 40-34-32-30-28-26-24-22 / Consolations: 18-14-12-10-8-6-4-2.

Final Results: One complimentary copy will be provided to every club entering five or more swimmers. Additional copies may be ordered for \$5.00 per copy.

Clerk of Course: **This is a positive sign-in meet. There will be clerk of course for 8 & Under events ONLY.** Seeding will be posted on the walls in the pool area for coaches and swimmers and in the hallways for parents. It is the swimmer's responsibility to be present at the blocks at time of their event.

Check-In: **This is a positive check-in meet.** Swimmers must check-in (sign in) no later than 25 minutes prior to the start of each session. **Swimmers who do not check in by this time will be scratched no exceptions.**

Schedule: **FRIDAY** – Warm Ups - Girls 5:00-5:25 p.m. Boys - 5:25-5:50, Start - 6:00 p.m.  
**SATURDAY & SUNDAY MORNING** – Warm Ups - Girls 6:45-7:15 a.m., Boys – 7:15-7:45. Start - 8:00 a.m.  
**SATURDAY & SUNDAY AFTERNOON** - Warm Ups begin after the completion of the morning session but not before 11:45 a.m. Session will start one hour and 15 minutes after warm-ups begin. 8 & Unders will have the first 25 minutes and OPEN will have the second 35 minutes.

Parking: **Note – Please park in the parking lot at the south end of the lot by the football field. Enter the building through the doors at the south end of the pool hallway.**

Concessions: Concessions will be available all weekend. Food and drinks will not be allowed on deck. SMOKING IS NOT ALLOWED ON SCHOOL GROUNDS.

Coaches: Coaches MUST constantly display their USA Swimming coach credential to gain deck access. The meet referee reserves the right to ask for coach credential display and/order deck access if coach does not comply. Information packets will be available to the club coach upon arrival at the meet. **NO PARENTS ON DECK AT ANYTIME.**

ATTENTION: Within the spirit of competition, there are occasions when conduct becoming a competitor is questionable. It will be the responsibility of coaches, assistant coaches, and team parents to monitor and be responsible for your swimmers. We would ask your cooperation in taking care not to damage property and to clean up your area before leaving for the day.
