**Meet Entry Policy**  
**Summer 2008**

- The CPSC coaching staff chooses all events for swimmers entered in the various dual, invitational, and championship meets which are offered.
- Fill out the Meet Sign Up Forms (one for you to keep and one to turn into the Head Coach) for the entire season and return to the Head Coach by Friday, April 18, 2008. Swimmers may choose which meets/days they will attend and the coaching staff chooses events for them. If you have a question about what meets your swimmer has the ability to compete in, please contact a member of the coaching staff.
- Parents may download meet packets from the meet schedule on our web site ([www.crownpointswimclub.org](http://www.crownpointswimclub.org)). The meet packets contain valuable information on meet sessions (am or pm), cost of events, warm up and meet start times, and location as well as other important information.
- Add/Delete forms may be turned in to the Head Coach before deadlines posted on the bulletin board, mailbox, and website to change meets or days (NOT events).
- Meet entry reports will be posted on the website and on the bulletin board at the high school, as soon as possible. If there are any questions concerning these entries, please contact the Head Coach.
- In the event there is a problem with your swimmer competing in a particular event (injury, illness, etc.) or if your swimmer would like to compete in a certain event (a long freestyle or other event that is not usually offered for your swimmer's age group), please contact Head Coach ahead of time. The coaching staff will try to accommodate a swimmer's needs if valid requests are made in advance. ***The coaching staff will not allow athletes to scratch events on deck at a meet (with the exception of illness or injury). In the event of injury or illness, the swimmer will be scratched from the remainder of the day's events.***

**Escrow Account Policy**  
**Summer 2008**

- An escrow account for each family will be set up at sign ups.
- The minimum amounts to be deposited into escrow accounts are as follows:
  - Red Group = \$35.00
  - White Group = \$55.00
  - Black & Gold Group = \$75.00
  - Senior Group = \$75.00
- Additional deposits can be made throughout the season as needed per the club Treasurer's escrow statements.
- Fees for meet entries will be deducted from your escrow account as the season meets progress. These fees include, but are not exclusive of, individual event entry fees, Indiana Swimming athlete surcharge fee, relay entry fees, meet administration fees, travel fees, and conference meet fees.
- You are responsible for your meet entry fees even if your child does not swim unless an Add/Delete form is returned to the Head Coach before the deadline for that meet.
- It is each family's responsibility to keep enough money in your escrow account to pay for the events your swimmer(s) will participate in. If there is not enough money in your escrow account, your child WILL NOT be entered in the following meet. The treasurer will send out escrow statements occasionally during the season; however, it is your responsibility to check with the treasurer if you are unsure of your escrow balance ([mpartim@ameritech.net](mailto:mpartim@ameritech.net)).
- The average cost for a summer season invitational is approximately \$30.00/swimmer/meet. Younger/less experienced swimmers would be less, the more advanced/Championship level swimmers may be more.
- A state championship level swimmer will need approximately \$200.00 in escrow to cover the summer season.
- Please keep enough in your escrow account – this will make the treasurer's job much easier!
- Any money left at the end of the season will either be kept in escrow for the next season or returned to you by check (if requested).
